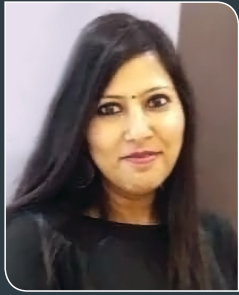

N. R. Narayana Murthy

- ◆ He is the President of the Infosys Science Foundation, which governs the Infosys Prize, an annual award, to honor outstanding achievements of researchers and scientists across six categories.

The scion of change

Narayana Murthy, Indian software entrepreneur who cofounded Infosys Technologies Ltd., the first Indian company to be listed on an American stock exchange. He is a pioneer of change and leads the way for others to follow in his footsteps to innovate and create something meaningful and different.

Murthy earned a bachelor's degree in electrical engineering from the University of Mysore in 1967 and a master's degree in technology from the Indian Institute of Technology, Kanpur, in 1969. During the 1970s he worked in Paris, where, among other projects, he helped design an operating system for handling air cargo at Charles de Gaulle Airport. Returning to India, he accepted a position with a computer systems company in Pune, but eventually he decided to launch his own company. He co-founded Infosys with six fellow computer professionals in 1981.

Building the right path

The company grew slowly until the early 1990s, when the Indian government's decisive move toward economic liberalization and deregulation contributed to dramatic growth in the country's high-technology and computer sectors. Murthy aggressively expanded his company's services and client base, negotiating deals with many overseas businesses to provide them with consulting, systems integration, software development, and product engineering services. By 1999 Infosys had joined NASDAQ, becoming the first Indian company to be listed on an American stock exchange. The following year Asiaweek included Murthy in its Power 50, the magazine's annual list of the most powerful people in the region. In addition, BusinessWeek named him one of its "Stars of Asia" for three consecutive years (1998–2000), and he was Fortune magazine's 2003 Asian Businessman of the Year.

Murthy stepped down as chairman in 2011 after 30 years with the company but returned in 2013 to hand over management to a professional CEO in 2014.

Giving back

N.R. Narayana Murthy is also known for his work on corporate philanthropy in India. Murthy has dedicated a huge amount of time and money to help his country and the people. He has said that developing countries need philanthropy more than developed nations for a simple reason: there are lots of poor people and the Government cannot do too much because of its limited resources. He therefore feels that it becomes the responsibility of the civil society and the corporations to add value to the efforts of the government by making sure that the society becomes better, be it through educational initiatives, healthcare initiatives or nutritional initiatives.

In November 2006, TIME magazine voted Murthy as one of the Asian heroes who have brought about revolutionary changes in Asia in the last 60 years. Three decades after floating and making Infosys a global software major, its founders led by NR Narayana Murthy are joining hands again - to promote philanthropy. To fund philanthropic activities and encourage entrepreneurship, four of the seven original promoters and their family on Monday jointly sold off 32.6 million shares of Rs 5 face value in the blue-chip company.

He serves on the boards of Ford Foundation, Rhodes Trust, and the UN Foundation. He has served as a member of the HSBC board and the Unilever board. He has served on the boards of Cornell University, Wharton School, and the Graduate School of Business at Stanford University. He has also served as the Chairman of the Indian Institute of Management, Ahmedabad.



Building dreams with perfection & craft

Ar. Prem Nath is a man of many virtues and is better regarded as a 'legend' among the architecture fraternity. His progressive ideas and design sense make him eye architecture from a very modernistic worldview.

The iconic Indian architect Ar. Prem Nath's design philosophy is 'Stay ahead of time.' He always mentions that in life nothing comes readymade but we have to take inspirations from various people in our life. He says that he has been inspired and stimulated by works of many other designers, which help me to get a cue or an idea to create his own distinctive work. In his journey as an architect, he has continued to learn and grow as a designer. He is never satisfied with the work he does and always looks for ways to excel even more with more detail and direction. He easily says that he finds fault with some of his previous works also, but he doesn't shy away from owning up to it. Rather, what makes him stand out among his contemporaries is his faith in accepting mistakes and learning from them to grow and excel with more learning.

Building Excellence

Ar. Prem Nath is a trailblazer and has built many iconic sites in his lifetime such as the first revolving restaurant in India above the Ambassador hotel in Mumbai. For him, the most memorable project and experience is the Country's 1st fast-track I.T. Building with a total construction area of about 130,000 Sqft. He informs that this project stands out as a prime example of fast-track conceptualization and execution of a large-scale project. The entire project was completed in a record time of eight months from the initial concept to handing over. Innovative techniques of construction were applied to achieve this goal. The latest path-breaking technologies were put into the picture. The building orientation and external cladding material help in cutting down the heat load so that the structure is energy-efficient.

One of India's leading architect-designer, Ar. Prem Nath's story is nothing short of a miracle and can be coined as the 'rags to riches' story. He began his career doing odd jobs such as a balloon seller and saved money to study architecture in the evening. Today, when narrating his story, it is easy to note that he has excelled in a wide array of projects viz. residential and commercial complexes, IT/sez parks, integrated townships, hotels-resorts, malls-multiplex, and high-end residential. But all that didn't happen in a day but required perseverance and hard work.

This approach is crucial for success because when we identified high cost of EVs as a barrier in higher adoption, we went ahead with localised manufacturing which resulted in cost reductions.

It helped us to tap the opportunities and aspirations in the Indian markets and enabled us to come up with offerings that matched both needs and demands. This strategy assisted us to go for expansion and create differentiators to help us reach the position where we stand today.

THE JOURNEY AHEAD

We are strongly aligned with the vision of Make in India. We have seriously focused on boosting our domestic manufacturing and research capabilities by efficient utilisation of resources to take local to global.

Going ahead in this direction, we have made dedicated efforts to develop the EV ancillary cluster in Vadodara, Gujarat. This is aimed at providing unique solutions to localise and strengthen the supply chain of raw materials. This will be a key enabler in India's EV growth in the coming years. It will boost local production, support holistic development of EV industry and manufacturing of essential components like electric motors, chassis, steel parts, lithium-ion cell manufacturing units, battery assembly units, chargers, controllers among others. This will further create a host of opportunities for the local population in terms of revenue generation and employment generation, ultimately leading to their empowerment.

The country has advanced in setting up robust battery manufacturing capabilities which is also the need of the hour. A battery is the most important component of an EV and makes up 30-40% of the total cost. To make EVs affordable, we need to cut reliance on foreign imports, mostly from China. Innovation, research and development have a critical role to play here. They need to be in focus of EV businesses also to withstand disruptions, remain competitive and become future-ready.

In this line, we have partnered with a leading Singapore-based renewable energy management firm and are going to set up a committee of experienced scientists, engineers and analysts for future developments.

We have plans to set up our first Global R&D headquarter in Singapore. WardWizard is in the process of hiring senior scientists from Germany and Japan, who will be based in its Singapore research and development (R&D) centre. Our major focus will be on developing the roadmap to the 1GWg cell production plant in Vadodara. We will be saving 24-28% on costs because of in-house cell manufacturing. The savings will be passed on to customers and will also improve distribution and our financial position.

We are also going to identify leading testing and certification agencies to set up a center of excellence for battery testing at Wardwizard premises. This will be a shot in the arm for us to draft a standard quality specification for batteries to ensure quality and reliability for our range of models. It will also bring benefits such as decrease in price and increase in efficiency and quality of batteries.

In the coming period, we have plans to set up a li-ion

manufacturing plant, and new products are ready to be developed including electric high speed scooters. We are further planning to enter the electric three wheeler segment with e-rickshaws. We will establish the Centre and Global sales office in Singapore as part of our global expansion plans.

Our targets are clear—supporting India in becoming a global EV manufacturing hub, transforming the future of the country's roads to electric, empowering communities and meeting the sustainability goals. A promising future awaits the EV industry. India today has all what it takes to emerge as a leader in EV space and its most valuable asset—the young population gives it a competitive advantage. Path-breaking innovative ideas, creativity need to be backed with strong leadership and technology to ensure the opportunity is not missed and help Indian take the pole position in the global EV race.

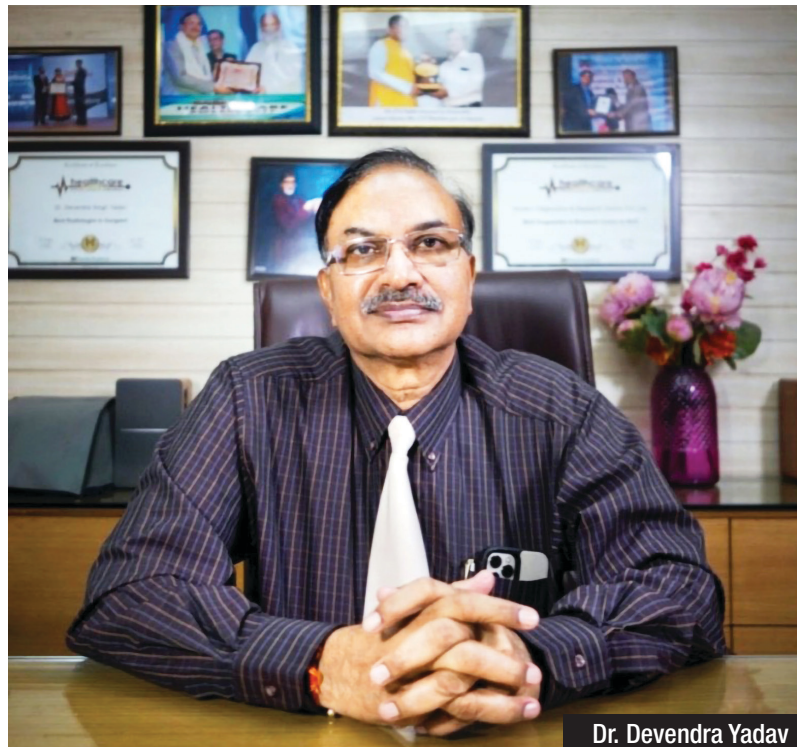

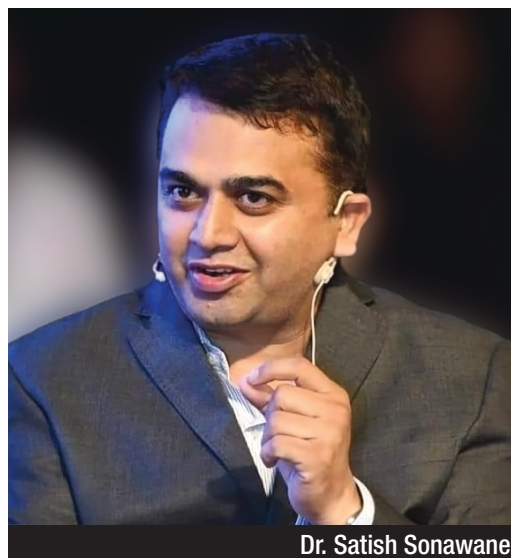

Along with the community sometimes government mechanism plays their part in adding pressure. However, being steadfast in its duties and principles GSS carries on with its noble mission.

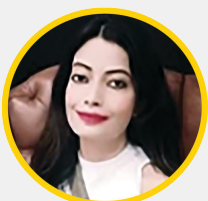

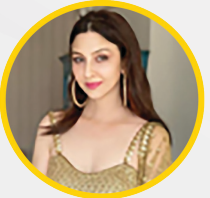
